BE IT ORDAINED:

Section 1. The County Council makes the following findings of fact: An emergency appropriation is necessary in the Emergency Communication Systems and Facilities Program Fund 170, for the 2018 budget year, in the total amount of \$3,500,000, to provide expenditure authority for financial obligations arising under the Interlocal Agreement for Emergency Radio System Replacement Between Snohomish County and Snohomish County Emergency Radio Systems.

Section 2. The appropriation unit and allocation detail of the emergency appropriation are as follows:

5 time of budget approval and appropriation for the year 2018 and hereby authorizes the
