20 unexpected funds in the amount of \$5,089,719 from the Alderwood Water & Wastewater District
21 (AWWD) made available after the adoption of the 2020 budget, and that a supplemental
22 appropriation is necessary, in the County Road Fund 102, for the 2020 budget year, to provide
23 additional expenditure authority for AWWD work related to two Transportation Improvement
24 Program projects within the Engineering Services Reimbursable program budget.
