13 **An Act**

14 To amend the annual salary of the Principal Chief and the Assistant Principal Chief in accordance with
15 Article VII of the Osage Nation Constitution, and to establish an alternative effective date.

17 *Be it enacted by the Congress of the Osage Nation:*

19 **SECTION 1. FINDINGS**

- 20
21 A. Article VII, section 10 states “The annual salary and expense allowance for
22 the offices of Principal Chief and Assistant Principal Chief shall be
23 prescribed by Osage law and shall not be increased or diminished during
24 that term of office.”

26 B. A General election will take place by law in June of 2022.

28 **SECTION 2. AMENDMENTS TO 15 ONC § 21-103(A)(1) AND 21-103(A)(2)**

30 15 ONC 21-103(A)(1) and 21-203(A)(2) shall be amended to read:

32 A. The following salary and expense allowance is authorized to the named
33 official:

37 a. Annual salary of one hundred fifty thousand dollars

40 b. Annual expense allowance of seven thousand five hundred

- b. Annual expense allowance of six thousand dollars (\$6,000.00) paid in equal pay period installments; and
- c. Benefits.

SECTION 3. ALTERNATE EFFECTIVE DATE

This bill is effective on July 5, 2022, upon signature of the Principal Chief or upon signature of the Speaker of the Osage Nation Congress following legislative override.


