

CITY OF BELLEVUE, WASHINGTON

ORDINANCE NO. 6610

AN ORDINANCE 1) amending the 2021-2022 General Capital Investment Program (CIP) Fund to increase the appropriation by \$195,000 with funds donated by Amazon; 2) amending the 2021-2022 Operating Grants, Donations, and Special Reserves Fund to increase the appropriation by \$195,000 to transfer Amazon donation funds to the CIP Fund; and 3) amending the 2021-2027 CIP Plan to increase the budget for Parks Renovation and Refurbishment Plan (CIP Plan No. P-R-11) by \$150,000 for improvements at Kelsey Creek Farm, Northtowne Park Playground and Bellevue Botanical Garden; ESI Implementation (CIP Plan No. CD-46) by \$35,000 for Citywide tree planting; and Neighborhood Enhancement Program (CIP Plan No. NEP-2) by \$10,000 for the installation of bat houses at the Lake Hills Greenbelt.

WHEREAS Amazon donated \$1,439,000 to the City to support the Human Services fund with \$1,000,000, community-identified neighborhood enhancement projects with \$289,000, and park improvement projects with \$150,000 in May 2021;

WHEREAS funds in the City's 2021-2022 CIP Fund and budgeted for the Parks Renovation and Refurbishment Plan (CIP Plan No. P-R-11) will support parks improvement projects; and

WHEREAS funds in the City's 2021-2022 CIP Fund and budgeted for the ESI Implementation (CIP Plan No. CD-46) and Neighborhood Enhancement Program (CIP Plan No. NEP-2) will support community-identified neighborhood enhancement projects; now, therefore,

THE CITY COUNCIL OF THE CITY OF BELLEVUE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. The 2021-2022 General Capital Investment Program (CIP) Fund, is hereby amended to increase the appropriation to said CIP Fund \$195,000 with funds donated by Amazon.

Section 2. The 2021-2022 Operating Grants, Donations, and Special Reserves Fund is hereby amended to increase the appropriation by \$195,000 to transfer Amazon donation funds to the CIP Fund.

Section 3. The City's 2021-2027 CIP Plan, is hereby amended to increase the project budget for Parks Renovation and Refurbishment Plan (CIP Plan No. P-R-11)


by \$150,000 for improvements at Kelsey Creek Farm, Northtowne Park Playground and Bellevue Botanical Garden; ESI Implementation (CIP Plan No. CD-46) by \$35,000 for Citywide tree planting; and Neighborhood Enhancement Program (CIP Plan No. NEP-2) by \$10,000 for the installation of bat houses at the Lake Hills Greenbelt.

Section 4. This ordinance shall take effect and be in force five (5) days after passage and legal publication


